Who are we?

ADAS host the www.planet4farmers.co.uk website and hold a list of registered users for each of these software tools.

How do we collect information from you?

We collect information from you when you register to download the PLANET or MANNER-*NPK* software from our website (<u>www.planet4farmers.co.uk</u>) or if you telephone to request a CD copy of PLANET, MANNER-*NPK* or ENCASH.

What type of information is collected from you?

The personal information we collect might include your name, address, email address and the software for which you have registered. If you download the software from our website you will be asked to set a password for the website so you can login again in the future.

How is your information used?

We record numbers of registered users for the PLANET, MANNER-NPK and ENCASH software; by registering for the software you agree for us to store your data. Your email contact information may be used to send you updates which are directly relevant to the software you have registered for. For example, we may email you to let you know if a new version of the software has been released, if we have identified a 'bug' in the existing software, to notify you of a change to the end user licence, or occasionally to ask for your feedback on the software tools.

We will retain your information on our systems until either -

- i. You notify us that you wish to be removed from our list, or
- ii. Defra (the licensor for PLANET, MANNER-*NPK* and ENCASH) terminate the end user licence.

Who has access to your information?

Your data will only be used by ADAS to contact you about the software for which you have registered. We will not share your information with third parties.

Your choices
